Terms and conditions

Introduction

This document lays out our terms and conditions of storage. Please read them carefully and provide a signed copy to indicate that you have read and understood them and agree to comply with all terms and conditions whilst storing your goods with us.

Insurance

1. It is your responsibility to provide full and accurate description of goods and accurate value of goods to us in advance of any storage of goods. 2. We reserve the right to refuse storage of an item if these conditions are not met. 3. Any costs incurred to us as a result of incorrect information being provided by you, will be paid in full by you, even if goods are not stored, including any associated domestic or international delivery charges or packing material cost and labour. 4. It is your responsibility as the owner to ensure your goods are insured to the full value of the goods prior to being stored. 5. We will not be liable for any loss, theft, fire or damage to your items. 7. You accept the goods will not be insured whilst stored unless you have provided your own insurance to the full value of the goods.

Ownership of goods

1. You must be the owner of the items or have permission from the owner or the responsibility of care for the items. 2. We will not arrange storage for any item that is not your property or that you do not have permission to store. 3. We reserve the right to ask you to provide evidence of ownership or evidence of granted responsibility for the item(s).

Description of goods

1. It is your responsibility to provide full and accurate description of goods and accurate value of goods, we reserve the right to refuse storage of an item if these conditions are not met and any associated costs incurred to us will still remain your responsibility to pay.

Condition Reporting

1. We will carry out if requested at the appropriate rate, a condition report for items being stored. 2. Condition checks should be carried out before the movement of goods. 3. The owner should be present during the condition reporting and both parties should agree on the satisfactory completion of each and any condition report. 4. If these conditions are not met, we cannot accept any liability for items description varying from that of the condition report, nor shall any claims be made against us for inaccuracy of condition reporting

Limited liability

We accept limited liability for items handled and stored by us. If an item becomes damaged due to our negligence, we agree to pay up to, but not exceeding £200.00 British sterling towards the repair or replacement of the item, whichever is less.

Damage and Loss

We do not accept any liability for damage or loss which occurs to unchecked goods whilst in our care. (Goods deposited with us, which are packed and not checked).

Storage locations

We may from time to time need to transfer your goods to a location other than that listed in this agreement. We will always communicate this with you in writing before any physical relocation of goods takes place.

Handling

We accept limited liability for items handled by us, in the event of damage during handling due to our negligence we will cover the cost of repair or replacement up to £200.00 British sterling.

Packing

We will not accept responsibility for any loss or damage due to packaging, unless we have packed the items our self, in which case we will only accept limited liability toward to cost of replacement or repair up to the value of £200.00 British sterling.

Restricted Items

We will not store any prohibited items, infested items, drugs, livestock, weapons or hazardous goods under any circumstances

Payment

Payment must be made in full on receipt of invoice. If payment is not made with 30 days of receipt of an invoice, we reserve the right to pass this amount onto a debt recovery agency. This may affect your credit score.

Recovering debt through the sale of goods

We reserve the right to sell any property that is stored with us, in order to recover any debts which cannot be repaid. We will never take this action without informing you first. This would only be a last resort and we would rather settle any outstanding amounts through other means.

By accessing and using this service, you accept and agree to be bound by the terms and provision of this agreement. In addition, when using these particular services, you shall be subject to any posted guidelines or rules applicable to such services.
